\$11.5 million spent on statewide ballot questions in 2008

Corporations, unions and other entities reported spending \$11,516,215 to support or oppose three questions on this year's statewide ballot, according to an analysis by the Office of Campaign and Political Finance.

Question 1, asking voters to repeal the state income tax, generated the greatest amount of spending this election cycle at \$7,918,157. Question 3, concerning a ban on dog racing, accounted for \$1,983,163 in spending. Additionally, \$1,613,895 was spent on Question 2, which asked voters to make marijuana possession a civil, not criminal, offense. The totals include inkind contributions and expenditures that were made independently of any organized ballot question committee.

The election results favored the side that spent the most money for all three questions. The supporters of Question 2 outspent opponents 20 to 1, the most disproportionate spending comparison of the three questions, in a successful campaign concerning penalties for marijuana possession. Question 1 opponents outspent supporters 15 to 1 to defeat the proposal to eliminate the income tax. Question 3 supporters outspent opponents 2 to 1 to pass a ban on dog racing beginning in 2010.

Of the entities that spent money to support or oppose ballot questions, the Massachusetts Teachers Union spent the most, \$3,468,241 to oppose Question 1. The National Education Association of Washington, D.C., spent the second most, \$1.5 million, also to oppose Question 1. The Marijuana Policy Project spent \$1,067,756 to support Question 2.

Total spending on the 2008 ballot questions fell \$4.6 million short of the \$16.1 million record set in 1992, when four questions were on the statewide ballot. The record for spending on a single ballot question is \$13.1 million, a mark set in 2006 concerning the sale of wine in food stores and \$5 million greater than the total spent by the Coalition for Our Communities ballot question committee in 2008 to oppose Question 1.

Three ballot question committees organized to support or oppose **Question 1** – Coalition for Our Communities was opposed, the Committee for Small Government and Citizens for Limited Taxation's Hell Yes on 1 supported the question. Coalition for Our Communities spent \$6,604,984, compared to \$481,102 spent by the Committee for Small Government and \$3,000 by the Hell Yes on 1 Committee. In-kind contributions to the committees, and independent spending by groups and corporations not affiliated with any committee, totaled \$830,071.

Question 2 had the least amount of spending among the three statewide ballot questions in 2008. The Committee for Sensible Marijuana Policy supported the question, spending \$1,218,388, while the Coalition for Safe Streets opposed it, spending \$63,172. In-kind contributions to the committees and independent spending totaled \$332,335.

The supporters of **Question 3**, the Committee to Protect Dogs, spent \$905,973. In opposition, the Massachusetts Animal Interest Coalition spent \$440,600. The total amount of inkind contributions and independent spending was \$636,063.

The figures in this study are based on reports filed by committees and other organizations covering the period through Nov. 15, 2008. Ballot question committees still in operation after Nov. 15 must file year-end reports with OCPF on or before Jan. 20, 2009. Those reports may include additional financial activity.

A ballot question committee receives or expends money or other things of value for the purpose of favoring or opposing the adoption or rejection of a specific question submitted to voters. There are no contribution limits concerning ballot questions, though statewide candidates are prohibited by the campaign finance law from contributing. Corporations, associations and organizations that make expenditures or contributions in connection with a ballot question are required to file CPF 22 forms with OCPF. The 2008 ballot question CPF 22 forms are posted in PDF form at the OCPF Web site: www.mass.gov/ocpf.
