LIABILITIES

970 CMR 2.12 e (2) requires that all expenditures and/or liabilities incurred on behalf of the joint fundraising event be paid in full. All liabilities shall be incurred equally by each sponsoring candidate/committee and, if necessary, each candidate/committee shall provide an equal share of funds so as to satisfy all debts incurred on behalf of the joint fundraising event.

DISTRIBUTION OF PROCEEDS

Net proceeds of the special committee or joint fundraising agent must be distributed to each sponsoring candidate/committee within 30 days of the event.
