The treasulat of a corporation, association, organization or other group of persons, other than a political committee organized under section 5, which has given, pake expended or contributed, or promised to give, easy expend or contribute, any money or other thing of value in order to influence or affect the vote on any question satisfyinged to the voters shall file reports setting forth the amount or value of every giff, payment, expenditure or contribution or provide to give; pay, expend or contribute, together with the date, purpose and full name and address of the person to whom it was made.

If the question appears on bellots at a scale election, such report shall be filled with the election as follows: (1) the sixtletti day prior to the election [complete as of the preceding tenth day]; (2) on or before the fifth and twentieth day of each month complete as of the preceding first and figurant day of the month, until the election; (3) the aventical day of November following such election, complete as of the Alberta day of the mouth, and (4) the twentieth day of January of cash year, complete as of the phirty-first day of December of the prior your, until all declared liabilities of such respectation, association, organization or other sport of persons have been discharged.

Any corporation, association, organization or class group of persons, other than a political committee organized under said section 5, violating any provision of this section shall be punished by a fine of not more than \$50,000 and any officer, director or ugent of they such corporation. association, organization or other group of persons violating any provision between or authorizing any such violation at any person who violates or to any way knowingly aids or abots the violation of any provision hereof shall be punished by a fine of not more than \$19,000 or by impresonment for not more than one year or by both such the and imprisonment,
