The treasurer of a corporation, association, organization or other group of persons, other than a political committee organized under section S, which has given paid, expended or contributed, or promised to give, pay, expend or contribute, any money or other thing of value in order to expenditure or contribution or promise to give, pay, expend or contribute setting forth the amount or value of every gift, payment, person to whom it was made.

If the question appears on ballots at a state election, such report shall be filed with the director as follows: (1) the sixtleth day prior to the election: (2) on or before the fifth and twentieth day of each month complete as of the preceding first and fifteenth day of the month, until the election: (3) the twentieth day of November following such election, complete as of the fifteenth day of the month; and (4) the twentieth day of association. organization or other group of persons have been discharged.

Any corporation, association, organization or other group of persons, other than a political committee organized under said section 5, violating any provision of this section shall be punished by a fine of not more than \$50,000 and any officer, director or agent of any such corporation, association, organization or other group of persons violating any provision hereof or authorizing any such violation or any person who violates imprisonment for not more than one year or by both such fine and imprisonment.
