### More than \$ 14 million spent by statewide office candidates

BOSTON - Over \$ 14 million was spent by candidates for statewide office during the 1994 election cycle, according to figures released today by the Office of Campaign and Political Finance. That figure was down significantly from the more than \$ 24 million spent by statewide office candidates in 1990, the most expensive election ever in Massachusetts history for the six constitutional offices.

In addition, the \$ 13.7 million raised by the 27 statewide office candidates in this year's primary and general elections represents a major decrease from the \$ 23.7 million raised by the same number of candidates in the 1990 elections.

A total of \$ 14,020,286 was spent by the 27 statewide candidates whose names appeared on the September 20, 1994 primary ballot and/or the November 7, 1994 general election ballot. Given the approximately 3.1 million Massachusetts citizens who were registered to vote in this year's elections, the spending breaks down to approximately \$ 4.52 per registered voter. The spending figures were taken from candidate bank reports filed during the period from January 1, 1993 through October 31, 1994. Sixteen of the 27 candidates began the election cycle with cash balances, accounting for the difference in the amounts of money raised and spent.

A total of \$ 4,788,147 was spent by the 20 statewide candidates in the seven weeks between the primary and general elections, while a total of \$ 2,137,281.65 was raised by those same candidates during that period.

By far, the most expensive race was that for governor, where the four general election candidates raised a total of \$ 561,926 and spent a total of \$ 2,043,155 during the period from September 15, 1994 through October 31, 1994. Combined with figures from the September primary election, over \$ 5.7 million was raised in this year's governor race, while more than

### \$ 6.1 million was spent.

The second most expensive race was that for treasurer/receiver general, where two candidates raised a total of \$ 526,192 between the primary and general elections, and spent a total of \$ 1,001,210 during that same time period.

The attached overview of the campaign finance accounts of the 27 statewide candidates includes their beginning balances, total contributions and total expenditures. The time frames used varied from candidate to candidate: those with statewide accounts in existence on January 1, 1993 began then; beginning dates for the remaining candidates were determined based on when the candidate designated his or her depository bank account to seek statewide office. The figures are preliminary based upon candidate bank reports filed through the period ending October 31, 1994. Because these reports have not been audited yet the figures are subject to change.

The Office of Campaign and Political Finance was established in 1973 to oversee and enforce the campaign finance laws with respect to all candidates on the state, county and municipal levels. In addition, OCPF maintains campaign finance records for all candidates and political committees in order to provide disclosure of these activities to the public.

## Over \$ 9 million spent by statewide candidates

BOSTON - Over \$ 9 million was spent by candidates for statewide office in the 1994 primary election, according to figures released today by the Office of Campaign and Political Finance. The monies spent by the 19 candidates whose names appeared on the September 20 ballots represent a decrease of approximately 55 percent from the 1990 primary election.

A total of \$ 9,230,263 was spent by the candidates in the period from January 1, 1993 through September 15, 1994. Those same candidates raised a total of \$ 11,650,967. Fourteen of those 19 candidates began the primary election cycle with cash balances, accounting for the difference in the amounts of money raised and spent.

By far, the most expensive race has been that for governor, where a total of \$ 4,083,163 was spent by four candidates since January 1, 1993. The second most expensive primary race was that for treasurer/receiver general, where two unopposed candidates spent a total of \$ 1,762,225. However, one of those two candidates spent \$ 1,629,396 of that total.

The following overview of the campaign finance accounts of the 19 statewide primary candidates includes their beginning balances, total contributions and total expenditures. The time frames used varied from candidate to candidate: those with statewide accounts in existence on January 1, 1993 began then; beginning dates for the remaining candidates were determined based on when the candidate designated his or her depository bank account to seek statewide office. The figures are preliminary based upon candidate bank reports filed through the period ending September 15, 1994. These figures are subject to change based on audits which will be conducted by OCPF.



### Over \$ 9 million spent by statewide candidates

BOSTON - Over \$ 9 million was spent by candidates for statewide office in the 1994 primary election, according to figures released today by the Office of Campaign and Political Finance. The monies spent by the 19 candidates whose names appeared on the September 20 ballots represent a decrease of approximately 55 percent from the 1990 primary election.

A total of \$ 9,230,263 was spent by the candidates in the period from January 1, 1993 through September 15, 1994. Those same candidates raised a total of \$ 11,650,967. Fourteen of those 19 candidates began the primary election cycle with cash balances, accounting for the difference in the amounts of money raised and spent.

By far, the most expensive race has been that for governor, where a total of \$ 4,083,163 was spent by four candidates since January 1, 1993. The second most expensive primary race was that for treasurer/receiver general, where two unopposed candidates spent a total of \$ 1,762,225. However, one of those two candidates spent \$ 1,629,396 of that total.

The following overview of the campaign finance accounts of the 19 statewide primary candidates includes their beginning balances, total contributions and total expenditures. The time frames used varied from candidate to candidate: those with statewide accounts in existence on January 1, 1993 began then; beginning dates for the remaining candidates were determined based on when the candidate designated his or her depository bank account to seek statewide office.
